



## RELEASE AND WAIVER

I (the "Participant") am aware that my use of the complimentary parcel check program ("Parcel Check") provided at the shopping centre known as Yorkdale Shopping Centre, located at 3401 Dufferin Street, Toronto, ON M6A 2T9 (the "Mall"), involves risks, including risk of theft, property loss, property damage, expense and related loss. I voluntarily accept and fully assume all such risks and the possibility of theft, property loss, property damage, expense and related loss.

Yorkdale Shopping Centre Holdings Inc., OPGI Management Limited Partnership and their shareholders, subsidiaries, controlled, related or affiliated corporations, successors, officers, directors, principals, agents, employees, third party contractors and assigns, as well as any mortgagee of the Mall (collectively the "Oxford Parties") have the right to refuse any items as part of the Parcel Check, at their sole and absolute discretion.

In consideration of Participant's use of aforementioned Parcel Check, Participant agrees:

1. To waive any and all claims that Participant has now or may have in future against the Oxford Parties as a result of Participant's use of the Parcel Check.
2. To release the Oxford Parties from any and all liability for any loss, damage to property, expense and related loss that Participant, Participant's next of kin, Participant's heirs, Participant's executors, Participant's administrators or Participant's assigns may suffer as a result of Participant's use of the Parcel Check, due to any cause whatsoever, including negligence, breach of contract or breach of any statutory duty of care.
3. That this Release and Waiver is binding on not only Participant, but Participant's next of kin, heirs, executors, administrators and assigns.

Oxford Parties have the right to open any sealed boxes or bags at their discretion. All items entering or leave the Parcel Check are subject to inspection by the Parcel Check staff. Oxford Parties are not responsible or liable for any and all articles checked, the contents of any and all articles checked or any and all items that are not collected by the closure of the Parcel Check on the day the articles were checked. Items will only be held during shopping centre hours, as deemed by the Oxford Parties. Any items that are not collected by the time the Mall closes will be delivered to Security as a lost & found item. Oxford Parties are not responsible for any lost or stolen Parcel Check tickets.

### **Please be aware that the following items are NOT accepted at Parcel Check:**

- Coats/Outerwear
- Purses or other personal belongings
- Medicine
- Jewellery
- Money
- Electronics (e.g. laptops, tablets, smartphones)
- Food and Beverages
- Bikes
- Car Seats/Strollers
- Dangerous items

**It is the responsibility of each Participant to remove any of the above items from the content of any parcel checks.**

I AM AWARE THAT BY SIGNING THE PARCEL CHECK TICKET I AM WAIVING CERTAIN RIGHTS WHICH I OR MY NEXT OF KIN, HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE OXFORD PARTIES. I HAVE HAD SUFFICIENT TIME TO READ THIS RELEASE AND WAIVER.**
